Subject: Request to HEIs for Identification and Academic Integration of SWAYAM MOOCs for the July 2026 Semester.

आदरणीय महोदया/महोदय,

As you may be aware, SWAYAM (<https://swayam.gov.in/>) is the Government of India's national online learning platform, offering high-quality Massive Open Online Courses (MOOCs) across diverse disciplines, thereby supporting the objectives of the National Education Policy (NEP) 2020 by promoting multidisciplinary learning, academic flexibility, and wider learner choice, while enabling students to earn academic credits. As per the UGC (Credit Framework for Online Learning Courses through SWAYAM) Regulations, the Higher Education Institutions (HEIs) may allow only up to forty per cent of the total courses being offered in a particular programme in a semester, through the online credit course, through the SWAYAM platform.

For the July 2026 Semester, the Ministry of Education has approved a list of MOOCs to be offered on the SWAYAM Platform developed by the National Coordinators (NC), namely UGC, CEC, NPTEL, IGNOU, IIMB, AICTE, NITTTR, and Institutions of National Importance, which is available on the SWAYAM portal (<https://bit.ly/445TNJs>) and is enclosed herewith for ready reference. The last date for course registration, NC-wise, is also enclosed. The HEIs are requested to ensure that students complete their course registration *on or before* the respective last dates.

Here, it may also be noted that the HEIs that have adopted the above UGC SWAYAM Regulations, 2021, and have also adopted the UGC Framework for Universities to conduct examinations for SWAYAM Courses (issued vide D.O.F. No. 1-8/2017 (SWAYAM) dated 27th August, 2024), may allow their students to appear in the SWAYAM Course End-Term examinations at their own campuses. This provision is in addition to the end-term SWAYAM Exam being conducted by NTA/NPTEL and facilitates greater accessibility and flexibility for learners.

To ensure effective academic integration and optimal utilisation of these courses, in the July 2026 semester, you are requested to:

- Circulate the list of approved SWAYAM courses among Deans, Heads of Departments, SWAYAM University Nodal Officer (SWAYAM UNO) of your institution.
